### Part B. CV SUMMARY (max. 5000 characters, including spaces)

1. The scientific contributions of the last 10 years have gravitated around 3 topics: urbanism/housing, gentrification and the link between these issues and insularity. The publications contributed in these matters are listed in section C.

1.1. In the field of urban planning/housing, special work has been done on the analysis and diagnosis derived from the second generation of neoliberal policies that broke out in Spain after the rescue of the Spanish economy in 2012. This analysis has been carried out both at the state level and in its specific implementation in the case of the Balearic Islands without neglecting some international examples.

1.2. As a singularization of these policies, intensive work has been done on the impact of gentrification on the affected urban societies and, especially, the geography of evictions and displacements implicitly linked to the aforementioned neoliberal policies.

1.3. Both neoliberal policies and their specific manifestation through evictions and displacements have been contextualized in the insular regions, especially in the Balearic Islands.

The results have been communicated in different congresses, conferences and, especially, in more than 20 publications that are listed in section C.

The financing obtained for scientific progress in these matters materialized in different projects and contracts that, in total, add up to €851,784, €361,834 in projects and €489,950 in contracts (see sections C3 and C4).

2. Contributions to society have been channeled through projects and contracts financed especially by public institutions listed in the previous table: Ministry of Science and Innovation, Govern de les Illes Balears, Consell de Menorca, and Ibiza Town Hall.

3. The contributions have meant that young researchers have been able to develop their research (Graduation Final Paper) and especially through the direction of 3 doctoral theses (Sònia Vives, Antoni Pons and Ismael Yrigoy) and have consolidated the GIST research group. He has collaborated as evaluator of 19 scientific journals, 3 books and 5 project evaluation commissions.

4. There are 5 six-year terms (research and transfer) and the regional complement for research and excellence in research.
