During the conference days, you can visit the "Smart Living Ethics exhibition" created by Simon Rogerson in collaboration with the Telefonica—Universitat Rovira i Virgili—Universitat de Barcelona Chair on Smart Cities. The exhibition explores the reach of smart technology and its social and ethical impacts on individuals, communities and the world at large. This novel exhibition comprises four towers covering living environments, real world examples, ethical hotspots and good practice. Tower sides usually have three interrelated exhibits.
